QUALIFYING CATEGORIES FOR WORK RISK ASSESSMENT

Use this table as the guide to assessing whether the Risk is low, medium or high.

Severity of Effect	Likelihood of Effect	Quantified Risk = Severity x Likelihood
1. No injury or minor injury. Injury not requiring treatment and no lost time.	1. Improbable. Less than 1 chance in 10,000 <0.01%.	<div>1-4 Low</div> <div>5-10 Medium</div> <div>11-25 High</div>
2. Slight injury. Injury requiring treatment but not resulting in loss of work.	2. Unlikely. More than 1 chance in 10,000 >0.01%	
3. Medium Injury. Requiring treatment and resulting in up to 3 day loss of work.	3. Possible. More than 1 chance in 1,000 >0.1%	
4. Significant injury. Leading to more than 3 day loss of work	4. Likely. More than 1 chance in 100 >1%	
5. Severe Injury. Leading to permanent disability or loss of life.	5. Probable. More likely to happen than not. >50%
